Public Procurement Policy- Atma Nirbhar Bharat, National Security, MSEs and MII, GFR Compliances& Public Procurement through GeM (With Latest Amendments)

INTRODUCTION: The Public Procurement Policy is a strategic instrument to advance India's economic and security objectives. By integrating Atma Nirbhar Bharat, Makein India, MSME promotion, land border safeguards, and GFR compliance, the policy ensures that government expenditure strengthens domestic industry, empowers small enterprises, and protects national interests.

General Financial Rules (GFR) are the main source of rules and orders of Government of India to be followed by all while dealing with matters involving public procurement and public finances. These rules and orders are treated as executive instructions to be observed by all Departments and Organizations under the central Government with certain exceptions where ever laid down. The aims & objectives of these rules is to provide a framework within which an organization may manage its business in a financially prudent manner without compromising its flexibility to deal with varied situations. GFR- 2017 has evolved from previous versions which enabled an improved, efficient and effective framework of fiscal management while providing the necessary flexibility to facilitate timely delivery of services.

During last few years Government has made many innovative changes in business delivery with a view to have Increased focus on Public Finance Management System(PFMS), transparency in procurement, schemes to ensure efficient delivery of entitlements, enhancements of e-processes like Central Public Procurement Portal, Government e-Marketplace (GeM), e-payments, Make in India Policy, Restrictions on GTE's and participation in tenders by the neighboring countries sharing land borders, Provision of Insurance Surety Bonds, Procurement Manual 2022/2024/2025, Model Tender Documents, Debarment, General Instructions, Proportionality in performance security, 'Vivad se Vishwas' etc. Some of these have substantially impacted the provisions in the GFR 2017 and various procurement guidelines. These changes are important and a Public Procurement Professional must be aware of the same with deeper understanding.

Government has shown the intent of focus on delivery in various instructions and amendments at the policy level, while maintaining the essentials of transparency in public procurement with equitable opportunity to vendors with fairness, free from the hassles, and aiming to continually enhance ease of doing business with government. It thus becomes important to have adequate and updated knowledge of developments in GFR, various guidelines & GeM for all executives associated with public procurement, particularly when decentralization is also happening simultaneously with enhanced delegation of powers at lower levels. PSUs have also to comply with the GFR and other guidelines on Public Procurement including MSME/MIIL preferences and submit mandatory feedback on compliance.

How to ensure compliance of varied public procurement provisions in the organisation and make effective decisions in line with government policy and avoid embarrassment and criticism? For this, it is very important for management at all levels and in particular at executive and middle level managers to know and understand the latest provisions of GFR. Government of India is also trying to bring more and more items in the ambit of GeM for procurement. How to identify these items as per requirements and how they will be processed for purchase?

This seminar will be beneficial for all critical stakeholders. It will help develop knowledge and ability for efficient procurement of items available on GeM. For faster learning, it is important to understand difficulties being faced by other buyers in identifying the product as per requirements and other procurement related issues. This seminar will provide opportunity for the same. The participant will also understand the mission and objectives of Govt. of India to move forward towards development of MSME sector, domestic manufacturing and ease of doing business in government with relevant GFR updates. The subject will help improve the delivery with improved system productivity & compliance.
